1. You will get your leave sanctioned from the Competent Authority before proceeding for the exams/ interview.
2. That UHBVNL will not bear any liability for your service in UHBVNL and that you will not be allowed any terminal benefits of your service in UHBVNL.
3. The passing of the exam/interview will not make you eligible for any further promotion in UHBVNL.
4. If you have selected/ appointed, before joining you will have resign from your present post in UHBVNL as per rules.
5. You will have to give one month notice as per offer of appointment or deposit salary as per rules.
6. You will have no right to claim your lien on the post of UHBVNL.

It is further added that Chief Accounts Officer, UHBVN, Panchkula have adopted Haryana Civil Services (Pension) Rule, 2016 vide Memo No. Ch-3948/ CAO/UH/PEN dated 20.12.2017 except Chapter (iv) Rule 15 regarding benefit of Past Service Benefit towards pension which is treated as deleted.
