Term & Conditions

1. He/She shall remain in service of BBMB as Medical Officer/Specialist/Dental Officer for a period of one year or till the appointment/transfer/deputation of regular incumbent by the partner States.
2. The service shall be of full-time nature with usual Gazetted & other holidays and he/she shall have to perform routine as well as emergency duties.
3. He/she will be provided status accommodation as applicable to the newly appointed doctors. If status accommodation is not available, then one step below accommodation will be provided.
4. The appointment shall be subject to medical fitness from a Medical Board constituted by BBMB.
5. The services of the doctor can be terminated by either party (doctor and BBMB) by giving one month's notice or one month's salary in lieu thereof.
6. The appointment will not confer any right of continuation, seniority, confirmation as well as any claim for regular appointment.
7. If the doctor commits any kind of misconduct or work not found satisfactory, BBMB shall have right to terminate this agreement after holding enquiry and he/she shall not be entitled to any compensation.
8. The doctor shall be entitled to get one day casual leave for every completed month of service.
9. No TA/DA will be paid for joining. However, he/she shall be entitled for TA/DA for outward journeys as admissible to the newly appointed doctors of Punjab Govt.
10. He/she shall be responsible for any legal implication arising out of his/her work & conduct.
11. Chief Engineer, Beas Dam, BBMB Talwara will be the final authority in case of settlement of any dispute and the same shall be confined to the territorial jurisdiction of BBMB.
