In pursuance to the decision taken in the 242nd Meeting of Board held on 15.07.2022 at Chandigarh under Item No. 242.07, approval of the Bhakra Beas Management Board is hereby conveyed to amend the following terms & conditions of the "Policy for Contractual Employment in BBMB", as issued vide this office order No.188/PD-3201/APD-4 dated 06.06.2014, as per details given below:-

- **To further amend & substitute Sr.No.3 as under (previously amended vide office order No. 197/PD-3201/APD-4 dated 06.06.2018).**

"The term of contractual employment will be extended in the spells of maximum one year up to the maximum age of 62 years. However, in case of an employee working at Power Plants, Workshops, Dams, Reservoirs, Hydrel Channels & its appurtenant works and for Operation, Protection & Maintenance of transmission lines, substations etc. who has technical expertise and posted in the field, for whom suitable substitute is not available, the term of contractual employment can be extended in the spells of maximum one year up to the maximum age of 64 years. This shall be subject to the condition that, the no. of such retired contractual employees working in BBMB beyond the age of 62 years and up to maximum age of 64 years at a time would be restricted to 30 no. only".

- **To amend & substitute Sr.No.6 as under :-**

The contractual personnel will be paid fixed emoluments as under:-

5	Steno Typist/Cashier/ALM/OC/ EM/ASSA/Crane Op /TG-II/ Work Mistry/Fitter/ Welder/Turner etc. & other equivalent posts having grade pay of Rs. 2750-3699	14,000/-
6	Peon/T-mate/Beldar/Helper/ Cleaner etc & other equivalent posts having grade pay of Rs. 1950-2749	10,000/-

- **To amend & substitute Sr.No.12 (ii) as under**

"Age of the applicant must be below the age specified at Sr. No. 3 above, as the case may be".

Note:- The revised emoluments as per amended at Sr.No.6 shall also be applicable to existing contractually re-employed employees and the revised emoluments to these employee shall be payable from the 1st date of the next month after issuance of this order. Other benefits/facilities which are already admissible under this Policy will remain as it is.
