- III. The employees would require making payment directly to the hospital
- IV. The offers as given by hospital be applicable on BBMB employees having valid ID cards /family marriages /gensioners (including family pensioners) having valid PPO as per the requirement of respective hospital.
- V. BBMB will not be liable for any financial/legal complications if arise in any case as per point (I) above.
