A Memorandum of Understanding (MoU) was signed on dated 03.08.2022 between National Institute of Technology (NIT), Kurukshetra & HVPN Power Training Institute (HPTI) on behalf of all Haryana Power Utilities (HPUs) i.e. HVPNL, HPGCL, UHBVNL & DHBVNL for conducting of Departmental Accounts Examination of its various cadres i.e. Engineering Cadre, Ministerial Cadre and Accounts Cadre.

2. National Institute of Technology (NIT), Kurukshetra has informed that the Departmental Accounts Examination (DAE) of various cadres of HPUs can be conducted during the month of December-2025/January-2026.
